Brief Description of Proposed Action: The HHHN Moreau Dental Services project entails transforming an existing primary care center into a modern dental clinic that meets HHHN's operational and regulatory requirements. The scope includes upgrades to the building's mechanical, electrical, and plumbing systems—such as new HVAC, specialized dental plumbing, electrical distribution, lighting, fire alarm enhancements, and a standby generator—along with the installation of compressed air and vacuum systems tailored for dental operations. Site improvements feature repaving the existing parking areas and driveways, new sidewalks, enhanced site lighting, a dumpster enclosure, updated signage, and landscaping.
