Request for Proposal

Work to be done:

1. Mill out failed binder
2. Install new binder
3. Remortor catch basins, top rings and all pipes
4. Install 1 1/2" risers on catch basins (steel)
5. Pave with 6Top asphalt at 1 1/2" compacted

1.) There is roughly 2080' of old binder to be milled out at 28' wide.

2.) Replace binder in milled area at 2.5" compacted (2080' x 28").

3.) Remortor all pipes & tops of 35 catch basins.

4.) Install 1 1/2" risers on 35 catch basins for 1 1/2" compacted 6Top.

5.) Pave with 6Top asphalt 215,072 sq. ft. consisting of:

a. 5,750' of 6Top x 28' wide

b. 3,004' of 6Top x 18' wide

c. All will be compacted to 1.5"

* Along with topcoat asphalt is a tack coat of approximately 1,450 gallons

6.) Clean up all areas disturbed.

All price quotes should include tonnage of asphalt to be used and gallons of tack coat. Itemization is required for all labor & equipment.
