The Supervisor welcomed everyone and stated that the purpose of this workshop was to gain public input. He stated that Marty Vanags was present from the Saratoga County Prosperity Partnership and that he had been working with the Town to come up with an economic development plan. He turned the meeting over to Mr. Vanags.

Mr. Vanags introduced Shelby Schneider and Jenny Kelley. He stated that the purpose of the workshop was to do a SWOT exercise. He asked that everyone divide into three groups.

Group #1: Councilman VanTassel, Councilman Hogan, Reed Antis and Cindy Kennedy Group #2: Councilwoman LeClair, Vince Sporrer and Tina Ovitt Group #3: Supervisor Kusnierz, Councilman Noonan and Tracy Clothier

Mr. Vanags stated that each group would be having discussion amongst themselves, to come up with two to three really good examples for Strengths, Weaknesses, Opportunities and Threats, with 5-6 minutes given for each topic. He asked that each group select a spokesperson.

The first topic was <u>Strengths</u>. Following a six minute discussion, the following group determinations were given:

Group #1:	Recreation Facilities Major Highway Corridor Available Infrastructure
Group #2:	Education – Reputable School System with access to higher learning facilities close by Leadership - Having a Supervisor who can lead the Town Board through the process Green Space
Group #3:	McGregor Prison Industrial Park Moreau Lake State Park

The second topic was <u>Weaknesses</u>. Following a six minute discussion, the following group determinations were given:

Group #2:	Traffic Congestion
	Too many apartments – not a stable population. Need a community where people belong

The third topic was <u>Opportunities</u> – external forces. Following a six minute discussion, the following group determinations were given:

Group #3:	Growth in communities around the Town of Moreau Opportunities for enhancing transportation, including freight line Gateway for retail & outdoor activities
Group #1:	Congestion north and south of Moreau - enhances the Moreau Rte. 9 corridor Industrial Park is a great opportunity – has power, water, sewer and rail Have a great opportunity to enhance the Town's communications through marketing
Group #2:	Opportunity for smaller businesses Location – Close to the Adirondacks, Catskills, Vermont and Massachusetts

The fourth topic was <u>Threats</u> – external factors that we have no control over. Following a six minute discussion, the following group determinations were given:

Group #1:	Traffic congestion – the exit 17 project (State project) will have an effect on the Town but will be out of our control to remedy the current congestion. New technologies – having to deal with The Town is not easy to do business with
Group #2:	Children go off to college and don't return. Need to grow the community so children will want to stay. We're losing generational families. Resiliency – Is the Town prepared in the case of a natural or economic disaster? Cost of living very high in New York State – difficult to keep people in the State
Group #3:	National climate for industry is declining External threats to the agricultural districts – Tariffs, housing Population is aging

Mr. Vanags put the post-it sheets up on the wall and Shelby Schneider went over each, asking if anything had been left out.

Under the Weaknesses category, there were a few added suggestions:

Lack of community interest

Community identity. It was suggested that Moreau become South Glens Falls. It was stated that having three different zip codes is a hindrance. Concerns with air pollution in the surrounding areas. And, pollution of the Hudson River

Under Strengths, the following suggestions were added:

Taxes are low in Saratoga County. Enormous capacity for public water and sewer

Under Opportunities, the following suggestion was added:

Sewer and water brings in business.

Mr. Sporrer asked if there would be a public hearing on the plan before it's finalized. Mr. Vanags replied no. Once the plan is delivered to the Town, it will be a finalized product.
