The 7-day Rolling Average Positivity Rate for Saratoga County is at 3% Total number of individuals tested throughout the County is 314,214

The number of residents to date in Saratoga County that have been in isolation or quarantine is at 25,315. The number of residents to date in Saratoga County that are currently in isolation is 3,807.

The Supervisor stated, that as Chairman of the Board of Supervisors, he has made it his priority for Saratoga County to be the first county in the State to get all their residents vaccinated. He stated, that as of yesterday, 26,371 or 11.5% of residents in the County have received at least one dose of the vaccine. 10,805 or 4.7% of residents in the County have received the second dose. He stated that Public Health has been doing a fantastic job. Most recently they've been working with BOCES to train public health school nurses to administer the vaccine. He stated that the County is moving in the right direction and the only limiting factor is the availability of the vaccine. He stated, that if the County can get access to the vaccine, they can get it out the door.

SERVER FIREWALL LICENSING AGREEMENT

The Supervisor stated, that when the Town updated the Firewalls as part of the 2019 project, the licensing agreement for the first year was included in the cost. The Town has received a quote from StoredTech for the license agreement renewals for the Town Hall building, the Highway Department and the Recreation Department. There were two quotes: Option 1 for a One-Year Renewal \$1,264.89 and Option 2 for a Three-Year Renewal \$2,316.60. The Supervisor stated that there was a significant savings if they go with the Three-Year option. His recommendation was to go with the Three-Year Renewal option.

SUPERVISOR'S ITEMS

The Supervisor stated that he had received an official letter from the United States Department of the Interior in relation to Grant Cottage. The letter was dated February 20, 2021 and was from the National Registry of Historic Places/National Historic Program. The letter advised that the Secretary of the Interior has designated Grant Cottage in New York, a National Historic Landmark. The Supervisor stated that this was good news because the Town of Moreau and Town of Wilton have been assisting Grant Cottage financially and it's been increasingly difficult. He stated that the Cottage requires a lot of upkeep to make it presentable to the public. He stated that he had met with Senator Schumer a few year's ago and he was going to try to get this designation. He stated that Congresswoman Stefanik was also involved in the process. The Supervisor stated, that because of this designation, it will open up the site to millions of dollars in Federal assistance.

The Supervisor stated that the County had received a limited supply of COVID vaccines, that per the Department of Health and the Governor's directive, could only be used for seniors. He stated that there were about 300 doses. There was a determination between the County Public Health and the Board of Supervisors to use the majority of the vaccines for seniors 75 and over, that couldn't get out of their homes. He commended the Moreau Emergency Squad for their participation on January 30, 2021, in getting the vaccine out to approximately 28 seniors in the Town of Moreau and the Town of Northumberland. These people would have otherwise been unable to receive these vaccinations. He thanked them for the the work they do to protect the public health and safety of our residents.

The Supervisor stated that the Town is in the process of purchasing an additional 50 acres contiguous to the Town's Recreation Park. Prior to moving forward on the purchase, the Town Board authorized a survey to take place. The Supervisor received notification that the field work has begun, and they expect to have it completed by late next week.

COMMITTEE REPORTS

Councilmember Hogan stated that there was an issue with the generator at the Town Hall and that it's been repaired. He also stated that there were some faucets in the Town Hall that have never had hot water and they too have been repaired. He stated that Pete Olesheski got them working properly. Councilmember Hogan stated that the Recreation Department is starting to get calls for the possibility of renting out pavilions this summer. He stated that this is something the Town Board will need to think about. He thought with the COVID numbers coming down, they might be able to rent out the pavilions with limited numbers of people.

Councilmember Noonan stated that the Intermunicipal Agreement with the Village for water is overdue and needs to be worked on. The Supervisor asked the Water Committee to see if the Town received the initial payments from last year and then they can go from there.

Councilmember VanTassel stated that he, Councilmember Noonan and Attorney Buettner met with NYSERDA. He stated that it was a good meeting and that NYSERDA shared perspectives from other entities that they work with. They had some recommendations that he and Councilmember Noonan will be bringing back before the Town Board. Councilmember VanTassel stated that NYSERDA thought the Town had done a good job and their only recommendation was to keep it simple. He stated that there are things that overlapped with the existing Town Code. Attorney Buettner is supposed to bring the draft law back to the Town Board once she gets the information incorporated.

Supervisor Kusnierz stated that he had spoken with Attorney Buettner on the draft Solar Law and thought that she had received some feedback from Planning and Zoning Board members.

Councilmember Donohue stated that they've discussed beefing up the Building Department. He stated that the Town of Moreau is exploding and that they need to look at fees that are charged, so budget wise they can look into increasing the department. He suggested that a committee could be formed to look into the matter. The Supervisor stated that they could form a sub-committee to look into this or they could have a Town Board workshop. Councilmember Noonan thought that there had been some suggestions made by the Planning Board on this subject. He stated that he would look back through his emails to see what he could find. The Supervisor also suggested that if anyone wanted to, they could reach out to other municipalities to see what their fees are. He suggested, Clifton Park, Halfmoon and Malta. He stated that the Town used to have a Building Inspector and an Assistant Building Inspector. He stated that he believed the Assistant Building Inspector is needed and that they would need to find creative ways to fund the position.

Councilmember Donohue asked where they were at with the Erie litigation. Supervisor Kusnierz believed that there was a court date set. Attorney O'Hara stated that he didn't know but that he would have Attorney Buettner advise the Town Board.

Councilmember Donohue asked the Supervisor if the Fire Company ever got back to him as to the reasons for needing their money up front. The Supervisor stated that they hadn't and that the contract is ready

and waiting to be signed. Councilmember Noonan stated, that as Fire Company liaison, he would reach out to them. Councilmember Donohue stated that he would like to know what their issues are. Councilmember Hogan recalled, during budget workshops, that they hoped to get their money up front so they could invest it, so they would be able to do more things.
