The Supervisor reported an increase in the 7-day Rolling Average Testing Positivity Rate to 3.3%.

The Governor has issued guidance with regard to outdoor ceremonies. Effective May 1, 2021, they will be allowed with limited capacity depending on the event size and location. Outdoor ceremonies of over 500 people will be limited to 20 percent of capacity, applicable to venues with a total capacity of 2,500 or more. Indoor event ceremonies of over 150 people will be limited to 10 percent of capacity, applicable to venues with a total capacity of 1,500 or more. The Supervisor stated that the updated guidance from NYS Department of Health, in relation to end of year celebrations during the COVID State of Emergency, will be on the Town's website.

# **NBRC GRANT APPLICATION**

The Supervisor stated that the Northern Border Regional Commission is a partnership between the Federal Government and the States of Maine, New Hampshire, New York and Vermont. He stated that it provides for an opportunity to secure infrastructure grants up to \$1,000,000.00. He stated that it would be a 50% matching grant. **WHEREAS**, the mission of the NBRC is to provide investments to job-creating projects that help reduce poverty, unemployment, and outmigration; and

**WHEREAS**, under said grant program, applicants are required to authorize an official representative to file the application; and

**WHEREAS**, the Town of Moreau plans to extend sewer infrastructure in the Route 9 commercial corridor to further future economic development efforts; and

**WHEREAS**, the Town of Moreau is eligible to apply for an infrastructure grant up to \$1,000,000 which must include a 50% local match; and

**NOW, THEREFORE, IT IS RESOLVED,** that the Supervisor is hereby authorized to execute and file an application on behalf of the Town of Moreau with the 2021 NBRC grant; and

**BE IT FURTHER RESOLVED**, that the Supervisor is hereby authorized and designated as the representative and to act as such in connection with the application to provide additional information as may be required including all understandings and assurances contained in the application; and

**BE IT FURTHER RESOLVED,** that the Supervisor is hereby authorized and directed to execute any contract and/or agreement executive's permission to sign any and all NBRC investment documents that bind the Town of Moreau; and

**BE IT FURTHER RESOLVED,** to the extent all or any actions hereby authorized have been executed and/or performed by the Supervisor all are hereby ratified and confirmed and this Resolution take effect immediately.

The Supervisor reported that the Town has received a letter of resignation from Crossing Guard, John Hayes, which is effective May 28, 2021. The Supervisor stated that he's done a phenomenal job for the Town. He stated that the kids love seeing him and Mr. Hayes liked dealing with the children. He was a great asset to the Town.

Councilmember Hogan asked if they should be interviewing for crossing guards. The Supervisor stated that they would have a discussion on this at a later date.

### SUPERVISOR ITEMS

The Supervisor stated that he had received a CC correspondence from Kristine Orr, Superintendent of South Glens Falls CSD, requesting authorization from the Board of Elections Commissioners to use their voting machines on May 18, 2021. No action is required on the part of the Town.

The Supervisor stated that the Town has received good news from the Environmental Facilities Corporation, in relation to the Engineering Agreement Amendment No. 2018107-01 dated March 26, 2021 for an endangered species impact study in the amount of \$2,875.00 between Laberge Group and the Town of Moreau, for the referenced water pollution control project. The scope of services was reviewed and found to be acceptable as being in compliance with applicable Clean Water State Revolving Fund (CWSRF) regulations. Costs associated with providing these services have also been found to be eligible for CWSRF financial assistance.

The Supervisor stated that he had reached out to Board Members in relation to a request from Moreau Emergency Squad. They typically purchase fuel for their vehicles from the Village of South Glens Falls, however, the Village will be changing out their pumps and the Moreau Emergency Squad will need to get their fuel elsewhere. The Highway Superintendent stated to the Supervisor that they can track the amount of fuel they use and that he was okay with the request. He did state that the Town's tanks are small and

may need to be refilled more often. The Supervisor stated that his office had polled the Town Board members and they were all okay with the request. The Supervisor asked the Moreau Emergency Squad for a copy of their fuel usage and from 9/1/2020 to 12/31/2020 they used 1,151 gallons of gas and 1,111 gallons of diesel. The Supervisor stated that they'll need a key to the pumps. He also stated, that at this point in time, it would be a temporary use.

The Supervisor stated that he completed a request for an application for funding through Congresswoman Elise Stefanik's office. The application was submitted through the Environmental Protection Agency's State and Tribal Assistance Grants (STAG) program, to supplement funding for the Town of Moreau's Wastewater Collection System Improvements Project/Water Meter Purchases.

The Supervisor stated that he had received correspondence from the Town's Zoning Administrator, looking for direction on where the Town wants to go with the recommendation of a change to the Local Code in relation to fences. He stated that they would take this up at the next Town Board meeting.

### **COMMITTEE REPORTS**

The Supervisor received information from the County that there is no eligible list for a Transfer Station Manager position. Therefore, the Town is free to advertise for the position. He asked the Board Members to come up with a salary range, so they can advertise.

The Supervisor reported that Councilmember Hogan has been working on the Town Hall fire alarm system replacement. The Supervisor stated that he was unhappy to learn, that at the time of the installation, the fire alarm system that was installed was already obsolete and that you couldn't get parts for it. He also stated that there was no warranty in effect. Councilmember Hogan stated that he had three quotes and was hoping that a fourth would be coming. The Supervisor thanked Councilmember Hogan for working on this and obtaining the quotes. He stated, that when they have the fourth quote, they can compile the information. Councilmember VanTassel stated that he has access to some people who will give a professional opinion on the subject matter.

Councilmember Donohue stated that he had spoken with the Recreation Leader regarding the chain that's across the metal recycling bin. He stated that it wasn't safe, and that Pete Olesheski would look into something safer, like a swing gate. The Supervisor thought that they had given the residents the option to just leave their recyclables outside the chain. Councilmember Donohue stated that large objects must be placed outside the chain, but small objects are left up to the resident. Councilmember Hogan stated that it should be employees only that throw the objects in the bin. The Supervisor stated, that if they move forward with the Transfer Station Manager position, there will be more oversight.

Councilmember Donohue stated that the Highway Superintendent did a good job improvising on the step to the loader, but it still swings and it's dangerous. Mr. Joseph told Councilmember Donohue that the unit is too old to get a replacement part. Councilmember Donohue stated that they need to do something, so no one gets hurt. The Supervisor stated that he would follow up on this.
