The Supervisor stated, that in New York State, the State mandates that the Assessor's office exempt wind and solar farms for real property on property taxes for 15 years. He stated that it was the State's effort to go-green. He stated, that there was legislation adopted, that would make the State obtain 50% of it's energy to renewable resources by 2030. To ensure that no tax dollars are lost, the Town is allowed to enter into a PILOT (Payment in Lieu of Taxes) agreement with solar developers or the system owner. PILOT's are collected in annual payments and they can't exceed the amount of taxes that would have been owed if the exemption weren't in place. The Supervisor stated that PILOT's are typically negotiated for a 15-year duration, with the possibility of a one-time extension for another 15 years. Taxing jurisdictions had the option to opt out of accepting these exemptions and allow solar farms to be fully taxable. He stated that the Hudson Falls School District, that serves property in the Town's Industrial Park, did opt out. He stated that the purpose of the public hearing is to allow the public to weigh in on the proposed Local Law.
