

A public hearing of the Town Board of the Town of Moreau was held on December 22, 2021 in the Town of Moreau Municipal Building, 351 Reynolds Road, Moreau, New York, for the purpose of hearing public comment on the South Glens Falls Fire Company contract for 2022.

The public hearing was held in person as well as broadcast via Zoom.

The Supervisor called the public hearing to order at 5:35 p.m.

The Supervisor explained that the public hearing was regarding the 2022 contract between the South Glens Falls Fire Company and the Town of Moreau, in the amount of \$557,551.00, for services rendered in 2022. He stated that there is also a provision in the contract for an additional \$50,000.00, to be put into reserve for the purchase of a new fire truck. He also stated that the Town pays 80% of the cost of the cancer insurance for eligible fire fighters and the Village picks up the remaining 20%. He stated that the amount equates to no more than \$4,000.00, at a rate of \$137.00 per eligible fire fighter. The Supervisor explained the payment amounts for each of the three scheduled payments. He then asked the Town Clerk to read into the record the public hearing notice.

The funds to be paid by the Town of Moreau to the South Glens Falls Fire Company, Inc. for these services are **FIVE HUNDRED SIXTY ONE THOUSAND, FIVE HUNDRED SIXTY ONE AND 00/100 DOLLARS (\$561,561.00)**. A copy of the proposed contract is available at the office of the Moreau Town Clerk located at the Moreau Town Hall.
