Dear Supervisor Fish:

Please find attached a draft copy of Change Order 5 for Town Board consideration. This document authorizes extra work for the installation of casing pipe if the Town cannot secure temporary easements by January 24, 2024. The document also changes the project's substantial completion date from December 15, 2023, to March 31, 2024.

Please note that the Contractor recommended the January 24th deadline based on his expected crew availability. Please also note that the Contractor reviewed the proposed change order language and asked that all work be authorized on a time and material basis. However, after discussion with our office, the Contractor agreed that change order provisions are sufficient since they require the Contractor to submit extra work details for approval by the Town.
