Last February, my son's former daycare closed, and I had very little time to look for new childcare. Luckily, she was referred to me by a friend, and I knew she would be a great fit from the moment I met her. She also sends pictures through the app, and it's the perfect pick me up during a hard day at work.

Finally, the look on my 5-month-old when she realizes we have arrived at daycare is so reassuring. She smiles so big, and I am able to hand her over with absolutely no tears. I couldn't imagine what I would have done or do if I didn't have T and Friends to bring my children to.
