### SET FUTURE MEETINGS AND WORKSHOPS

None

Councilman Kusnierz asked why the first 15 minute public comment period had been moved to a 30 minute public comment period at the end of the meeting. The Supervisor stated that there was a long list on the agenda and that the public would still have time to speak at the end of the meeting. The Supervisor asked if anyone had a problem. Councilman Prendergast stated that if people came her to speak, they shouldn't have to stick around and stated that they should speak.

#### **15 MINUTE PUBLIC COMMENT PERIOD**

Reed Antis stated that he had looked over the Solar City agreement with the Town and asked if anyone knew how much the Town would be saving. The Supervisor replied that the estimate is \$39,000/year. Mr. Antis asked if anyone had done up a spread sheet to show the savings and asked again what the savings would be he also stated that it will be placed on Town property so there won't be any taxes paid for that parcel. The Supervisor replied again that the estimate we were given is that the savings would be \$39,000/year for twenty years.

Terry Clark addressed the Board with a question as to when taxes are due. The Assessor replied that Town Taxes are due in January. He proceeded to ask the Board if they had all paid their taxes. All of the Board members replied yes except for Councilman Vittengl and his reply was "not yet". Mr. Clark stated that he didn't think you should sit on the Board if you don't pay your taxes. The Supervisor stated that it's not a requirement to sit on the Board and then told Mr. Clark that this wasn't a proper discussion. He stated that it's personal and not a Town issue.

Mr. Hughes asked how long the Zoning Laws have been in place as they are today. Supervisor Jenkins replied since 1989. He asked why the northeast corner of the Town has been zoned urban residential. The Supervisor didn't know why this was zoned that way in 1989 as he wasn't here at the time. Mr. Hughes

asked if there have been any amendments to the zoning since 1989 and the Supervisor replied that he thought there have been some minor ones. Mr. Hughes stated that where he lives, it's one apartment complex after the other. He stated that the lights are so high at one complex that it looks like you're driving by a Walmart. He asked about the complex going in at the corner of Bluebird and Harrison. He stated that one little piece is zoned a PUD. He asked how it went from an M-1 to a PUD. Supervisor Jenkins stated that it was a decision by the majority of the Town Board. He stated that Councilman Kusnierz had voted no to the PUD. Mr. Hughes stated that whole Northeast corner is being taken over by apartments. Councilman Prendergast stated that they tried marketing that area for over twenty years for industrial or light industrial and there were no takers. He stated that they had an option as leaving it as woods or putting it to use for the Town. Mr. Hughes asked why just this corner and aren't there any other places in Town to put apartments. Councilman Prendergast stated that the infrastructure is already there. Mr. Hughes stated that there's a big traffic problem. Supervisor Jenkins stated that property isn't conducive to normal housing because of the water level. He assumes that's why it was zoned that back then, but he doesn't know for sure because he wasn't on the committee.

# MR. AND MRS. MERRILL – DISCUSS TRUCK TRAFFIC

Mr. Merrill of 103 Sisson Road was present to discuss the concerns regarding Glens Falls Lehigh Cement's use of Sisson Road to gain access to their property. There was an agreement made back in 2008 to close the gate at the entrance to their property and build a berm to keep the dust and noise down. He has spoken with DEC and they agree that the gate is supposed to be closed. Mr. Merrill stated that the gate is being used and the truck traffic has increased. He stated that the increase traffic is also causing damage to the road. He would like to encourage Lehigh to create a more eastern entrance to the property. Mr. Merrill stated that there are new homes and apartment complexes with more pedestrian traffic, especially children, and no sidewalks. He stated that the truck route through his neighborhood presents a safety hazard to pets and kids. He stated that the gate was supposed to be closed and a berm built.

Denise Crete spoke to the Board and stated that at the time agreements were being made Mr. and Mrs. Merrill weren't happy with how high the berm was going to be. She stated that if it's not as high as it's supposed to be, it won't stop the dust or the traffic. She doesn't think that by closing the gate it would make a difference. She stated that there aren't any children that live on the dead end street. She showed a picture to the Board and stated that the road doesn't look much different from last year and that it's the plows and salt that are causing the damage not the trucks.

Mr. Merrill's suggestion is to move the gate further down and away from the development. He stated that he had spoken with the cement company regarding the matter and initially he was willing to change the gate and now they aren't. Paul Joseph stated that when the road was reopened he spoke to Joe Patricke about it and Joe stated that the Town has no way to keep it closed. Paul stated that the road is scheduled to be re-done next year and it will need reinforcement because of the truck traffic coming out of there. Paul stated that someone had called him from the cement company and asked what they would have to do to put a road further down across from Schermerhorn's new development. Paul told him he would have to go before the Planning Board. He advised him to call Joe Patricke and then was told that he didn't want to go through all the red tape to put in a construction road. Councilman Kusnierz stated that they're not responding to the neighbors and asked the Supervisor to reach out to the cement company. Paul Joseph stated that he was asked by the cement company if they could use the Fenimore Road and Paul told them it wouldn't be recommended due to the curves. Councilman Prendergast asked if there weight limits and Paul replied that there weren't any permanent weight limits. He also stated that weight limits are set by himself and the Town Board. They have paperwork that can be completed to change the limits. Councilman Prendergast suggested assigning a weight limit. Paul Joseph stated that the best solution is to put a new road in away from the housing. Councilman Prendergast agreed that the Supervisor should reach out to the cement company and look at alternate routes for truck traffic and if not, we can put weight limits on the road. The Supervisor thanked Mr. Merrill for his comments.

Gardner Congdon stated that he had been trying to get information that he believes is public information and that he's been told by the Town Clerk that she has to check with the Board before she can give out the information. He asked why he can't have what he asked for. The Supervisor stated that this was discussed last Thursday. Mr. Congdon stated that he wasn't here last Thursday and that what he wants to see is what was pulled out of the boxes he looked at. He stated they were in the basement and doesn't see what any of

the documents would have to do with attorney client privilege. He understands if it's ongoing litigation or a personnel matter that the Town would have a right to exclude it. He's looking for simple letters and advice regarding the IDA and the Industrial Park and what the agreement was for the hook-up of the sewer. He stated that the minutes show that there will be a pay in from Shermerhorn and Fran told him that she doesn't have any payments yet. He stated that the tax payers have 2.5 million tied up in the force main for industry only, which was the original purpose. He asked, as a tax payer, is he subsidizing Schermerhorn's apartments because it appears to him that he is. Unless the Town can pass the proper resolution changing the purpose of the force main to residential, then that would be fine with him. He stated the proper people would then be paying for the service. This started with an IDA grant which was a bond and a bank anticipation note for the first 4 years and now it's an interfund transfer and he's trying to find out who's going to pay the 1.2 million since 1996. He asked if Schermerhorn bought that or who paid for that. The Supervisor stated that the tax payers paid for it.

Councilman Kusnierz asked the Town Clerk if she found what Mr. Congdon was looking for and she explained that Mr. Congdon's FOIL asked for "everything on the Moreau Industrial Park" and that there was nothing specific that he had asked for. She stated that she had started to bring up the 8 boxes from the basement and that Pete Corlew happened to be at the Town Hall and helped. She and her Deputies started to go through the boxes to pull out anything confidential or attorney client privilege. She also mentioned that she didn't have to do this right away. She had sent Mr. Congdon a letter stating that his request was received and that within 20 business days would have an answer to his request. Mr. Congdon stated that he wasn't looking for copies, he only wanted to view the information. Mr. Congdon stated that he was told the Town Clerk was going by the advice of the attorney and the Town Clerk stated that she was going by the Freedom of Information laws and that she had to pull out anything that was privileged. Mr. Congdon stated that attorney client privilege is for ongoing attorney client relations. The Town Clerk deferred the question to the attorney for the Town. Karla Buettner stated that the Freedom of Information laws are not solely for attorney client privilege information and the exemption for attorney client is not solely for litigation. Section 87 lists all the exemptions within the Freedom of Information law and that counts whether you are copying the information or letting someone come in to look at it or if you are scanning and emailing it. Mr. Congdon stated that all he wants to do is look at the information and Ms. Buettner replied that the boxes had to be looked at to see if any of the exemptions applied. Mr. Congdon stated that he understood. Mr. Congdon asked if an attorney gave bad advice, the public can't know? He stated that he spoke with Mr. Freeman and he was told something entirely different from what the attorney had just stated. He stated that he would find out what he needs. Mr. Congdon also made a comment that he was right about the logs and asked if she remembered her advice, that it wasn't property and then stated that she found out something different. Attorney Buettner asked the Supervisor if he wanted her to respond to the question. Mr. Congdon stated that the comptroller agreed with him. Councilman Prendergast stated that if a FOIL is made the process will be followed. Mr. Congdon replied that it will be twenty days and the election will be over. He made comment about the tax payers not knowing what the tax rate will be before the election and stated that he always made the public aware.

Elizabeth Lanfear asked if the Town has done anything with the Time Warner contract and wanted to know when the contract is to expire. The Supervisor stated that the contract is open ended unless the Town makes a change. Councilman Kusnierz stated he couldn't give an exact date but thought that is was about 4-6 years ago. The Supervisor stated that this is an agenda item for later in the meeting.

# **REQUEST FOR HIGH SPEED INTERNET**

A letter was sent to the Supervisor and Town Board members requesting high speed internet. The Supervisor stated that there wasn't much the Town could do but make another request to Time Warner. Councilman Kusnierz stated that the reason the Board hasn't moved forward on a contract is because it's very difficult to deal with Time Warner. The Town has limited items to negotiate. He also stated that in this day and age, everyone in this Town should have access. He doesn't have it and because it's a mile down the road, it's cost prohibitive. With new technologies, there's now competition with Dish Network and others. He also stated that high speed internet is the 911 of the age. Supervisor Jenkins stated that he will try to schedule a meeting to speak with Time Warner. A gentleman asked how many businesses or homes this would serve and the Supervisor replied a couple hundred. He stated that they're spread out and you have to have so many within a one mile limit by the rules of the Public Service Commission and this is what protects them.

#### **CARBON MONOXIDE DETECTORS**

The Supervisor stated that information was received that the new code states you have to have (1) hard wired carbon monoxide detector per furnace. Councilman Kusnierz stated that this code wasn't in place when the Town Hall was originally built but that the Town would have to comply by June of next year. This item was tabled until they have more price information.

#### **15 MINUTE PUBLIC COMMENT PERIOD**

Vince Spoorer wanted to be clear and asked what the projected sales tax revenues are for 2015 and the Supervisor replied \$2.9 million. He asked how much the Town will be giving back to the County and Councilman Prendergast replied \$600,000.00 and that last year it was \$400,000.00 and \$800,000.00 in years before that. Supervisor Jenkins stated that it had been \$400,000.00 before and Councilman Prendergast agreed and stated that it has gone back and forth. Mr. Spoorer stated that by putting in a standard percentage, this would be the fairest. Supervisor Jenkins stated that what it boils down to is what you believe you need for the future. He stated that if it's split down the middle and stay with that then you can measure the County and the Town. Mr. Spoorer asked if the State mandates that the Town and County share the sales tax. Supervisor Jenkins stated that there are 16 Counties in the State that don't

give any sales tax back to the Counties. With the rest the amounts vary. The Supervisor told Mr. Spoorer that he could have a copy of the page that shows this information and that it is also on the internet.

Mr. Congdon stated that it would be helpful it they knew what the difference in the rate would be. So if someone had a \$400,000 assessment, what that would mean to them. He stated that there's a lot of confusion on this. He also stated that the gentleman doesn't understand that the Village gets their own sales tax by the same formula that the Town Outside gets their sales tax. Mr. Congdon expressed his opinion on the tax rates.

Rich Morris spoke regarding the money that was transferred into the General Fund from the tree cutting at the end of Nolan Road. He asked if that money will go back to Water District 2. Supervisor Jenkins replied that most likely it will but they will need to determine what portion of trees that were cut, were in Water District 2. He stated that there are records.

Gardner Congdon asked if there is a cost for this and the Supervisor replied yes that it would require someone to come in and mark it up. Supervisor Jenkins stated that the Board is going to do what's right. The Supervisor stated that he lives in Water District 2 and that the Board isn't trying to hurt anybody. Mr. Congdon stated that wasn't the case until he brought it up and the Supervisor replied that he wasn't aware of it. There was discussion between the Supervisor and Mr. Congdon relating to the contract and the flagging of the lots.

Mr. Morris made comment that he was disgusted with what happened with the tree cutting. He stated that in his opinion the estimated value of the trees is much more than what was paid. He stated that he spoke with Councilman Vittengl last fall and asked if they were going to cut all the premium oaks that were marked. He stated that Mr. Vittengl's reply was that he had seen it himself and that he wasn't going to let that happen. Mr. Morris told Councilman Vittengl that was a lie and that every tree was taken. Mr. Morris stated that the beauty of the peninsula has been wrecked. He stated that he had offered to help and Councilman Vittengl never reached out to him. He stated that now he's upset about it because you can never get it back. This was an asset to the Town that you can't get back.

Terry Clark made comment about his lawsuit with the Town of Moreau. He stated that he sued the Town and that the Town is suing Casale. Attorney Buettner stated that there are counter claims in the lawsuit. Mr. Clark stated that if the Town had just admitted that the contractor had messed up there wouldn't have been a lawsuit. He stated that the Town Board members have their heads in the sand. He stated that there were rumors out there on Councilman Vittengl. Supervisor Jenkins stated that we aren't going to talk about personal issues. Mr. Clark stated that he won't back down when he's right and stated that "you" will be embarrassed.
