The Town Clerk read the following Resolution and Determination into the record:

TOWN OF MOREAU TOWN BOARD MEETING APRIL 30, 2019 RESOLUTION AND DETERMINATION ESTABLISHING EXTENSION NO. 5 OF SEWER DISTRICT NO. 1 IN THE TOWN OF MOREAU, COUNTY OF SARATOGA, STATE OF NEW YORK, PURSUANT TO ARTICLE 12-A OF THE TOWN LAW OF THE STATE OF NEW YORK

WHEREAS, the Town of Moreau initiated proceedings to establish Extension No. 5 of Sewer District No. 1 in the Town of Moreau, County of Saratoga, pursuant to Article 12-A of the Town Law; and

WHEREAS, a map, plan and report relating to the establishment of the proposed Extension No. 5 of Sewer District No. 1 prepared by Laberge Group, competent engineers, duly licensed by the State of New York, in manner and detail as required by Article 12-A of the Town Law, has been filed with the Town of Moreau Town Clerk, in accordance with the requirements of Article 12-A of the Town Law; and

WHEREAS, an order was adopted by the Town Board of the Town of Moreau on June 12, 2018, reciting the filing of the map, improvements proposed, the estimated expense thereof, the proposed method of financing, the fact that the map, plan and report are on file in the Town Clerk's Office for public inspection, and all other matters required by law to be stated; and

WHEREAS, the order set June 26, 2018 at 8:00 p.m. at the Moreau Town Complex, 351 Reynolds Road, Moreau, New York as the date, time and place of the public meeting to consider the map, plan and report, and to hear all persons interested in the subject thereof, and to take such action as required and authorized by law; and

WHEREAS, such order was published and posted as required by law; and

WHEREAS, a hearing on the matter was held by the Town Board on the 26th day of June, 2018, beginning at 8:00 p.m. and the matter being duly discussed and all interested persons having been duly heard; and

WHEREAS, the Town Board did at that time resolve and determine to conclude and close the public hearing and to render a decision at a special meeting of the Town Board to be conducted on the 26th day of June, 2018 at the Moreau Town Complex; and

WHEREAS, the Town Board on June 26, 2018 approved the creation of Extension No. 5 of Sewer District No. 1 subject to the approval of the Office of the State Comptroller; and

WHEREAS, on April 9, 2019 the Office of the State Comptroller approved the creation Extension No. 5 of Sewer District No. 1 at a cost not to exceed \$16,000,000.00; and

WHEREAS, the resolution of the Office of the State Comptroller approving the creation of Extension No. 5 of Sewer District No. 1 is attached hereto and made a part hereof as Exhibit A.

NOW, THEREFORE, IT IS RESOLVED AND DETERMINED:

- (a) The notice of hearing was published and posted as required by law, and it is otherwise sufficient;
- (b) That all property and property owners within the proposed sewer district extension are benefited thereby;
- (c) That all the property and property owners benefited are included within the limits of the proposed sewer district extension;

- (d) That the public interest will be served by the establishment of Extension No. 5 of Sewer District No. 1 in the Town of Moreau in accordance with the application filed by the Town of Moreau with the New York State Office of the State Comptroller;
- (e) Since the Town of Moreau is receiving funding from the New York State Water Grant and a loan from Environmental Facilities Corporation hardship financing then the annual debt service to the property owner shall be based upon a benefit basis and will be spread across the properties within Extension No. 5 of Sewer District No. 1 on both an ad valorem basis and a parcel area basis such that the tax rate shall equal \$6.78/\$1000 on the ad valorem basis and that the parcel area rate shall equal \$74.77 per parcel acreage for the first year after sewer district extension formation; and
- (f) That operation and maintenance expenses shall be \$169,000 in the first year and allocated on a use basis at a rate of \$4.61 per 1000 gallons as measured by existing water meters, and at an ad valorem rate of \$1.22 per \$1000 of assessed value. Hookup fees are not included in the estimated maximum cost; and it is further

RESOLVED AND DETERMINED, that the establishment of Extension No. 5 of Sewer District No. 1, as set forth in the map, plan and report, be approved and that the requested improvements be constructed, and the necessary easements and lands be acquired upon the required funds being made available and provided for, and such district shall be known and designated as Extension No. 5 of Sewer District No. 1 in the Town of Moreau, and shall be bounded and described as set forth on Exhibit "B" attached hereto; and it is further

RESOLVED AND DETERMINED, that the Town Clerk of the Town of Moreau shall, within ten (10) days after the adoption of this Resolution, file a certified copy thereof, in the Saratoga County Clerk's Office and with the New York State Department of Audit and Control at Albany, New York; and it is further

RESOLVED AND DETERMINED, that the maximum amount to be expended for said improvement and/or acquisition of necessary lands is the sum of Sixteen Million (\$16,000,000.00) Dollars; and it is further

RESOLVED AND DETERMINED, all costs of said improvements shall be financed by the issuance of obligations pursuant to the Local Finance Law and that the repayment of those obligations for properties within the sewer district extension be done on a benefit basis as set forth above.

The Supervisor also stated that he had received correspondence form the Environmental Facilities Corp. on April 18, 2019, which stated that the EFC had reviewed the

Town's submissions and advised that the Town is eligible for Clean Water State Revolving Fund financial assistance. He stated that he would get the ball rolling to start the process.

MOREAU COMMUNITY CENTER

The Supervisor stated that the Community Center is looking to use the Recreation Park to have Senior Softball pick-up games. They've asked the Town Board to waive the fee for the field use. The Supervisor stated that they passed a resolution in June of 2018 allowing them to play at no cost. The Supervisor stated that David & Nancy Salazar were in attendance to discuss the upcoming Pow Wow. There was a lengthy discussion regarding the operation of the Pow Wow and the concerns that have arisen over the past few years. There was mention of vendors hooking into Town water and power, vendors camping overnight and smoking on Town property. Ms. Salazar stated that she wasn't aware that the vendors were using Town power and water. Mr. Salazar stated that the event has been in the Town for 46 years and doesn't want to lose the event. He stated that they want to comply with the Town requirements. Councilman VanTassel stated that there has been a lack of communication over time. They need to figure

out specifically what the Pow Wow wants to do, so the Town knows how to staff the event. They were asked about the dates of the event and Mr. Salazar replied that it would be held from July 4th through July 7th. Participants will start coming in on Thursday from 7pm to 10pm and the shows will start Friday evening and continue through Sunday. Mr. Salazar stated that there are approximately 200 participants with 300-400 spectators. He was asked how many people stay overnight and Mr. Salazar replied that there were a little over 100 people. They were asked how many vendors would be participating. Ms. Salazar replied that there were around 20. At the conclusion of the discussion, Councilman VanTassel stated that they need to work out the details and suggested that they schedule a time that the Rec Committee can meet with the Salazar's. He stated that he would like to have Dave Jones present for the discussion as well. They can at that time, work out the framework and see who's responsible for what. He stated that he would reach out to them tomorrow to set a date and time to meet.

MUNICPAL INSURANCE RENEWAL

The Supervisor stated that the Insurance Committee met with the Town's representative, Dave Meager. Councilman Hogan stated that there was a recommendation that the Town sign up for IT insurance. Councilwoman LeClair stated that the coverage for Cyber protection will increase from \$50,000 to \$100,000 on June 1st if the coverage is already in place. PRIVILEGE OF THE FLOOR

Dominic Tom of Cedar Lane addressed the Town Board with a formal request that the Town consider instituting a partial tax exemption on real property for persons with disabilities or who are on limited incomes. He asked the Town Board if they could get the ball rolling. Mr. Tom stated that he had received an email back from the Assessor stating that she wouldn't be able to work on this until July.

Mr. Tom also stated that there was a previous discussion regarding 1592-1596 Route 9 and commented that he had received a response from the Building Inspector stating that he was sending a letter to the property owner(s) with the list of violations. He had asked the Building Inspector if the owner(s) were cited for any violations and has received no response. He also asked if the Town is going to order an emergency demolition. The Supervisor stated that he had received an update today on the mentioned property. He stated that it is to be purchased and the building is to be demolished. He stated that he was hopeful that the issue will be resolved.

Reed Antis addressed the Town Board. He commented that the coverage for 61 Hudson Street listed in the insurance proposal was \$367,000 and felt it was too high. He suggested that with the new sewer project coming, that the Town hire an independent "clerk of the works" to make sure everything gets done. He commented on the LED lights and stated that if the Town buys them, they own them and will be responsible to replace them.

He stated that he hoped property owners would be notified of the eminent domain with regard to the sewer project. He also commented on buildings to be demolished and stated that Terry's Motel should be as well.

SUPERVISOR'S ITEMS

The Supervisor stated that he had attended the SGF Fire Company's annual installation banquet and swore in the new officers. He stated that he had also presented a proclamation from Senator Jordan recognizing Tom Tracy for his service to the community for the past 65 years in the Fire Company.

The Supervisor reported receiving a notice from Saratoga County Water Authority that they would be flushing hydrants starting the week of April 22, 2019. They hope to have the job completed by the first week in May. The Water Superintendent stated that he had shut down their water for two days when they were in the area, so there wouldn't be any problems.

The Supervisor read a second letter from Charter Communications: Effective on or around May 13, 2019, Charter will launch Spectrum Originals on-demand on channel 2010. The channel is free to Spectrum video subscribers.

The Supervisor stated that his office had received a request from the Saratoga County Fair asking to hang a self-supporting promotional banner, which has been ok'd in the past. The Town Board was in favor of the request.

The Supervisor received correspondence from NYS Agriculture & Markets regarding the Municipal Shelter Inspection Report, which was completed on March 14, 2019. Dog shelter services were rated satisfactory.

The Supervisor stated that he had received a flyer from the Moreau Community Center regarding the annual Village of South Glens Falls/Town of Moreau Garage Sale. It will be held June 1st and June 2nd, 2019. The flyer also indicated that there will be free concerts on Tuesday's at 6:30 p.m. from June 25th through August 27th. He stated that the SGF Chamber of Commerce may be contacted for more information.

The Supervisor stated that all Board members should have a copy of the official Comprehensive Plan. He also stated that it's now on the Town of Moreau website.

The Supervisor stated that today was the cut-off date for comments on the MS4 compliance report. He stated that no comments had been made and that he has signed off on the report.

Councilman Hogan stated that the had met with the Town's insurance representative and offered information to Dave Jones regarding a free seminar on Playground Inspection Maintenance and Managing Playground Liability to be held in Malta on June 4, 2019 from 8:30am to noon. He thought that Dave and Bruce Siergiey may want to attend.

Councilwoman LeClair stated that she had been working on how the Town is going to comply with the State's requirements for Sexual Harassment training. She was advised by the Association of Town's that NYMIR had a program and the State of NY also has an on-line program. She stated that the State's program is interactive and after the employee is done watching the video, they would write down any questions they have, that would have to be answered by the person in charge of the organization, which in our case would be the Town Supervisor. She stated that after the employee has watched the video, there is a sheet that would have to be signed stating that they have completed watching the video and they would have to answer four questions related to the video. Attorney Buettner stated that she had information on workplace violence training and that she would get together with Councilwoman LeClair. Councilwoman LeClair stated that they might be able to do the training all at one time.

Councilwoman LeClair stated that Dave Jones had looked at the old Town Hall building at 61 Hudson Street. She stated that that he recommended work that needed to be done, which included the replacement of some roofing slate. She stated that if anyone knew of any contractors, to pass that information along to her.

Councilman Noonan stated that Kevin Gifford from the American Legion VFW, is looking for information on Veteran's in their final resting places in our cemeteries. He stated that the Town has money budgeted for the purchase of flags and stated that he would speak with John to see how they can get the flags placed on the proper burial sites. He stated that he would keep the Town Board posted.

The Supervisor stated, that as a member of the Board of Supervisors, a Supervisor each month honors a deceased veteran in Saratoga County at a ceremony and reception that's videotaped. He stated that he is looking for recommendations.

Councilwoman LeClair stated that Ted Monsour is looking into getting three prices for the repair of the roof over the compactor at the Transfer Station. Once that's been completed, he'll have the area sprayed and sanitized.
