A public hearing was held by the Town Board of the Town of Moreau on November 5, 2020 in the Town of Moreau Municipal Building, 351 Reynolds Road Moreau, New York for the purpose of hearing public comment on the proposed 2021 Preliminary Budget.

The Supervisor called the public hearing to order at 5:30 p.m.

The Supervisor gave a brief overview of the preliminary budget. He stated due to many reasons but primarily due to the COVID-19 pandemic it has had a great impact not only on the 2020 budget but also how they structured the 2021 budget. He stated this is a very conservative budget but continues to meet the needs of the residents, and it also reflects an anticipated drop in sales tax. He said they realize now and continue to realize that. He also stated they know based on the County Treasurer's estimates they will begin to see a reduction in year to date for the sales tax in 2021. It's a major factor in putting together this budget because so many of our funds rely on funding through the sales tax that they receive from the County.

He stated they conservatively estimated the sales tax for 2021 to be around \$2.39 million dollars. He also said in this budget the tax rate remains essentially flat with last year, just over \$97.95 per assessed thousand. So what this will do based on the Town's assessed value is that we will be raising \$1.441 million dollars in taxes. The good news he stated was that they were able to increase the funding for first responders. They were able to increase the allocated sales tax by 2% for fire protection. He said this budget also stays within the State's tax cap, it was a primary focus for the Board when the budget was put together. If the tax cap is broken it has a negative effect on the residents who receive certain types of property exemptions.

The Supervisor stated they were able to do such a conservative budget because in 2020 they had earmarked some big projects that needed to be taken care of. One was the Highway Garage roof, that alone was an expense of \$467,000. Also there were two unfilled positions in the Highway Department. They decided not to include them in this 2021 budget. That was a savings of \$121,000 in savings. He stated that was also equally important that one of his goals when he took office was to put a budget together that was sustainable and didn't rely on fund balance. They have been slowly weening themselves off the amount of money that they use for sales tax. He stated the General fund balance that they need to use in this budget alone was reduced by 81%. He said they reduced using fund balance in Highway DB fund by 49% from last year. The Town outside B fund was reduced by 59%. They were also savings of fund balance for the water districts 2 and 5, they will be using zero fund balance in those accounts. Also water district 4 was reduced by 36%.

Councilmember Noonan stated he thinks the Supervisor did a great job for a tough budget year, referring to the COVID-19 pandemic. Councilmember Donohue said he thinks with the uncertainties with the Sales Tax it's a fair budget, save what we can and keep it to the minimum because we don't know what we are going to be facing. Councilmember Hogan stated that between Supervisor Kusnierz and Jeffrey Cruz the budget that was put together was fair, and considerate to the community.

Supervisor Kusnierz wanted to add one more thing and thought the public would be interested in knowing. He stated that there was a story in the paper regarding whether or not we are going to send sales

tax back to the County. He stated if you read the story or the headline, you got the impression that County tax for the Town of Moreau residents was going to go up. He said the first thing there is no way of knowing that because the County budget had not been released until today, and the actual tax rate has gone down from last year. He stated that was not an accurate statement of what the actions of the Board are sending sales tax or not to the County.

Supervisor Kusnierz read the following statement aloud:

I have confirmed with the Attorney for the Town that tonight's preliminary budget public hearing has been convened in accordance with the Governor's March 13, 2020 Executive Order 202.1 and all extensions, which suspends certain provisions of the Open Meetings Law to allow a municipal Board to convene a meeting via videoconferencing. In accordance with the Executive Orders, the public has been provided with the ability to view and participate in tonight's meeting and a transcript will be provided at a later date. The Town Clerk has done a roll call of the Board Members and there is a quorum present for this meeting. I have also confirmed with the Town Clerk that this meeting has been duly noticed. We have fulfilled our legal notice requirements by posting Notice on the Town's bulletin boards/door, sending to the news organizations, etc, and posting notice on the Town's website. This is being recorded and a transcript will be prepared.

As you know, we have our public hearing for the 2021 preliminary budget scheduled for tonight. I will open the public hearing, and if you wish to be heard, please use the "CHAT" or "Raise Your Hand" feature or, if you are on the phone, please state "Question". We will allow everyone who wishes to speak do so. Please address any comments or questions to the Board and speak slowly. After the public hearing is closed, we will not accept any further comments on the budget. Thank you for your understanding in this time.

The following notice of public hearing was published as a legal ad in the Post Star Newspaper on October 31, 2020. The Deputy Clerk read the notice aloud as follows:
