They are currently the kind that lift & should be the type that slide. Pete Olesheski & Mike Hastings are going to brainstorm to come up with a fix and do it in house. Supervisor Kusnierz suggested we change the spacing and maybe heighten the cones as people are changing lanes and driving off with the cones under their cars. Councilmember Donohue stated that Mike has been speaking with O'Connor Construction as they are interested in the mulch. We're waiting for a call back to find out what they're willing to pay for it. The money would go into the General Fund and would offset the cost of the grinding.

Councilmember Stewart brought up the memo from Highway Superintendent Joseph regarding the "Call-In, As Needed" rate for the Highway Department. Supervisor Kusnierz stated that this will be discussed during the upcoming budget workshops.

Councilmember Donohue stated that he ran into State Representative Carrie Woerner recently, and he asked if her office had any funds they could contribute toward our Recreation plans. Ms. Woerner told him to get a proposal together and send it to her office. Supervisor Kusnierz stated that she has been very easy to work with in the past and has helped with the sewer infrastructure as well.
