BKM PROPERTIES LLC

Project on south side of Exit 17 would require a local law as it involves a lot line adjustment that includes two differently zoned areas. The proposed change would increase residential from 23.54 to 27.23 acres and decrease commercial from 52.83 to 49.14 acres to create a buffer for the residents. They would all be separate lots and wouldn't add to the current lots. It would also include a conservation all along the western section that will be forever wild.

Councilmember Stewart asked about the one property that wasn't included on the map because the line goes behind it. If that parcel is currently zoned commercial and the change would make all the area around it residential, Councilmember Stewart is concerned that there could be an issue with the neighbors down the road. Mr. MacKenzie stated that the parcel in question currently has a single-family home on it.

Supervisor Kusnierz reminded everyone that a notice would go out to all the people within 500 feet, and there would have to be a public hearing. Councilmember Noonan suggested talking to the property owner in question to ask if they would want their property rezoned residential. It is technically non-conforming to the commercial requirements.

Attorney O'Hara stated that the Planning Board would need to get involved. Supervisor Kusnierz described that a local law would have to be drafted, the Town Board would have to review it, and a public hearing would be scheduled after hearing back from the Planning Board. The Town attorney will begin drafting the law for review.

If it is put in the Highway fund, it can't be moved. If it is put in the Town Outside account or the General Fund, it can be moved.

The Supervisor reported on sales tax. We just got our allotment for October. Moreau received \$356,247.00. It's a 5.81% decrease from 2021. Some of the other towns in the county have larger reductions. We're still in a good position financially and are getting more revenue than we're budgeted for.

The Rec Leader sent a memo regarding increasing fees for tournaments. One of the issues in the past was waste disposal. The Supervisor would like the Rec Committee to look at it and come up with a recommendation prior to the next Town Board Meeting, so that the Board can act on it. The Rec Leader will need that information prior to getting requests for softball tournaments for 2023.

The Supervisor stated that he was involved in establishing a Saratoga County Fire Department and EMS Agency Recruitment Grant Fund Program. The County earmarked \$100,000.00 of AARPA funds to be used for this. The County Board decided to give each organization around the county a flat amount to help with their recruitment efforts. Last week the Moreau EMS was given a check for \$2,273.00 and Supervisor Kusnierz spoke with the Fire Company and gave them the information so that they could apply for the grant as well.

Supervisor Kusnierz stated, that as part of the mandated 2023 - 2026 Community Health Assessment, the Saratoga County Health Department has released a survey for residents to share feedback about the health issues and concerns that are important to them. They can complete the survey by going to the Saratoga County website.

Supervisor Kusnierz informed everyone that the Planning and Zoning Board Secretary has provided her resignation effective October 27, 2022, which is after the next meeting. Brenda from the Supervisor's office has agreed to sit in on the next meeting to find out what goes on in case we don't have someone in place prior to next month's meeting. We'll have to have someone in mind for that position going forward and advertise for that position.

We had advertised to fill a position at the Transfer Station, but we never filled it. Councilmember Donohue asked if we could re-advertise for the position. Councilmember VanTassel said that he'd check with the Town Clerk's office about any applicants. Mike from the Transfer Station stated that if he could get one more person down there, we wouldn't have to hire anyone to replace Betsy. Councilmember VanTassel stated that he didn't know if we had posted the position anywhere but social media.

It was hard to get an exact count. Councilmember Donohue discussed feedback he received about people staying there for hours. There were food trucks and other activities. Councilmember Noonan stated that it's a great event, and it's wonderful that it is organized by people outside of the Town. Supervisor Kusnierz gave special thanks to Falls Farm and Garden for loaning us the tractor free of charge to use for the wagon rides.
