The Supervisor stated that the Saratoga County Board of Supervisors is sharing \$5,300,000.00 in funds that were earmarked to go to the towns based on the sales tax formula. \$326,168.00 is earmarked for the Town of Moreau, which will be deposited into the General Fund. The Supervisor thanks his colleagues on the Saratoga County Board of Supervisors for their cooperation on the resolution.

The Supervisor acknowledged that the Dog Control Inspection Report was received on December 21, 2022. Everything was copacetic. There is a copy in the Supervisor's office for anyone who would like to review it.

The Supervisor indicated that our Special Counsel collaborating with us on Water and Sewer provided correspondence specifying that the final resolution order and determination of the Town Board was recorded in the Saratoga County Clerks office on December 16, 2022 in relation to our 202-b proceeding.

The Supervisor advised that his office will be sending out a newsletter which will go out before the end of the month. A new law impacting the real property tax law was signed into effect in December 2022. It requires that all residential property owners be notified that senior citizens have another exemption for which they can apply.

The Supervisor confirmed that our Assessor is teaming up with other assessors around the county and is looking for direction from the Saratoga County Real Property Tax Service department regarding an exemption for Volunteer Firefighters and Ambulance Workers.
