NOTICE IS HEREBY GIVEN pursuant to Section 184 of the Town Law and Section 122-b of the General Municipal Law, that the Town Board of the Town of Moreau shall conduct a Public Hearing at the Moreau Town Hall, 351 Reynolds Road, Moreau, New York on January 31, 2023, at 6:35 p.m. for the purpose of receiving public comment on a proposed contract between the Town of Moreau and the Moreau Emergency Squad, Inc. Under the proposed agreement, the Moreau Emergency Squad, Inc. will furnish emergency and general ambulance service within the Town during calendar year 2023. The funds to be paid by the Town of Moreau to the Moreau Emergency Squad, Inc. for these services is **TWO HUNDRED FIFTY-FIVE THOUSAND, AND SIXTY and 00/100 Dollars (\$255,060.00)**. In addition, the Moreau Emergency Squad, Inc., on behalf of the Town, will charge and collect fees, established by the Town Board for ambulance services in the Town. The Moreau Emergency Squad, Inc. will be solely responsible for billing and collection of the fees. A copy of the proposed contract is available at the office of the Moreau Town Clerk located at the Moreau Town Hall.
