Supervisor Kusnierz listed the fees charged in surrounding communities, provided by Director Brogan-Queensbury charges \$150, Glens Falls charges \$85 +\$100 deposit, Gavin Park charges \$250, Saratoga State Park charges \$125-\$300. Lake George is free for residents and \$150 for non-residents, and Halfmoon charges \$200.

<u>Discussion</u>: Councilmember Noonan said he did not support an increase in the fee to residents, stating it was free for residents when he started on the Board. Councilmember Stewart said based on the work that goes into maintaining the facilities, the cost of waste removal, and the direction of services in the park, he believes \$50 for residents is more than reasonable. Even at the new rate, he said the Moreau Recreation Park Pavilion rental costs less than half the price of pavilion rental in neighboring towns. Councilmember VanTassel said he respected the views of the other councilmembers, and that he would like to work with Councilmember Stewart and Recreation Director Brogan to make sure fees are equitable but also cover the Town's expenses.

RESOLVED, that the town board of the Town of Moreau be designated as the lead agency with respect to the environmental review associated with the adoption of Local Law No. 4 of 2023 pursuant to Part 617 of the State Environmental Quality Review Act; and it is further

RESOLVED, that the town supervisor be authorized to sign any and all documents associated with the environmental review regarding adoption of Local Law 4 of 2023 pursuant to Part 617 of the State Environmental Quality Review Act."

Supervisor Kusnierz reported that mortgage tax receipts for the period November 1-30 totaled \$26,020.50. Also, he said the Town had met what it anticipated for 2023 sales tax. He said \$2,051,496 was allocated to the Highway Department DB fund, \$605,499 to the general fund, 571,196.80 to fire protection SF fund, and \$138,114 Town outside of B fund. He said he expected approximately \$500,000 to remain at the end of the year which needed to be allocated. He recommended allocating a percentage since the final numbers were unknown at the time, specifically 80% of recognized funds to the general fund A1120 and 20% of recognized revenue funds be allocated to fund B1120. He said these funds could be used for a Town-wide recreation project capital reserve fund to pay for recreation upgrades.

Upon consensus of the Board, Supervisor Kusnierz read a prepared resolution:

"Whereas, the Town of Moreau has received sales tax in excess of the estimated amount adopted in the 2023 budget, and

Whereas the Town Board of the Town of Moreau is invested in the expansion of recreational projects and activities throughout the Town of Moreau,

Be It Resolved, that the sales tax received by the Town of Moreau in excess of the estimated amount adopted in the 2023 budget be allocated as follows:

80% to be recognized as revenue to the general fund and posted to account code A1120, and 20% to be recognized as revenue to the Town outside fund and posted to account B1120.

So, Be It Further Resolved, that the amount allocated to the general fund in account A1120 from this resolution be transferred allocated to the townwide recreational project capital reserve fund to be recognized as revenue and posted to account code HT5031 interfund transfer."

### PRIVILEDGE OF THE FLOOR

Brigid Martin said she found it interesting that a man who spoke previously saying he couldn't afford sewers for 2500 people he moved into town had his attorney at the meeting as well as his office manager. Councilmember Donohue asked what this had to do with Town business. She said she wanted to keep the sewers to account and this may be their motivation, that the sewer brings jobs, that you can't vote out businesses that want to grow and then complain there aren't jobs. She said three people from an organization that paid to overturn the government want to extend it(?) a couple of months so the new administration can waive their rates. She said she thought it highly suspicious. She said it was a false equivalency to compare 2500 residences with Hudson Headwaters. She said the 2500 residents did not have jobs, questioned where they work, and said they are all from somewhere outside of Moreau. She continued, saying the sewers are bringing development along Rte. 9, and that people wanted to come to Town but members of the Board "shot them down." She ended by saying she thought the sewers were a good idea to keep the Town growing, and that "crooks" who are getting by paid off by multi-millionaires should be kept out of office.

<u>Gina LeClaire</u> said her son lives in Schermerhorn apartments, and that if petitions that were given to the Town were reviewed, it would be apparent that she and others knocked on many residents' doors. She said the people who live in the apartments are happy, and are not "out-of-towners," but include local seniors and locals like her son. She said many people cannot afford a

\$300,000 home but want to live in Moreau to be near family. She continued saying many people who live there greatly appreciate the service his apartments provide. Supervisor Kusnierz questioned if this was a Town issue. Councilmember Donohue questioned the Supervisor about what the previous commenter's Town issue was. Ms. LeClaire said the previous speaker was wrong about the quality of the residents and the apartments and thanked Mr. Schermerhorn.

<u>Elizabeth Bennett</u> asked about the Recreation Park pavilion rental rate increase passed by the Board earlier in the meeting. She asked if the Town currently charges the schools to use the facilities, giving Moreau Elementary School as an example. Supervisor Kusnierz said he believed the Town waives the fee on a case-by-case basis. She questioned if there was an actual rule regulating school fees. Councilmember Stewart said he would look into whether there is a policy regulating school use during school hours. Ms. Bennett said following the conversation about the refund of tournament dollars due to foul weather, where the refund is being disallowed for lack of a policy allowing it, if there is no policy, she asked how it can be permissible to waive the pavilion rental fees to the schools.

The Supervisor said that by statute the Town Board can deviate from Town policy. He gave as an example, the BOCES program, which provides valuable service to the Town, saving hundreds of thousands of dollars over the years. BOCES students learn skills and gain experience working on projects at the Recreation Park. At the end of the training season, he said they request to use a pavilion, and the Board has waived the fee each time. She agreed and said her children had participated, but that did not answer the question about the schools and a policy regarding their use of pavilions.

Councilmember VanTassel wanted to go on the record to say that no one on the Board had made derogatory comments about Mr. Schermerhorn's properties, the residents thereof, or the quality of life his properties offer.
