- c) On its' own terms if the Town Board doesn't extend it.

Councilman Kusnierz thought the Board had to make progress on a local law in order to have a moratorium.

Attorney Auffredou said they couldn't extend a moratorium if they weren't making progress, but it doesn't cease to exist because the Board isn't making progress.

Supervisor Jenkins said if there were no further comments he asked for a motion to close the public hearing.

A motion was made by Councilman Cumm and seconded by Councilwoman LeClair to close the public hearing at approximately 7:00 p.m.
