The source of potable water for Extension No. 3 of Water District No. 1 is the Town of Queensbury. The Town of Moreau has an agreement to purchase water from the Town of Queensbury and has constructed a Hudson River crossing to access the source. The Town will incur all costs for the creation/extension proposed water system. These costs would include the preparation of plans, the engineering report and construction of the water system and its appurtenances. According to the Map, Plan and Report, the estimated cost to extend the

district and install the water transmission mains and necessary water infrastructure is approximately \$181,642.62.

According to the Map, Plan and Report, the estimated total yearly cost for an average residential customer will be approximately \$433.00.

The Map, Plan and Report describing the improvements is on file in the Town Clerk's Office and is available for public inspection.

The Town Board will conduct a continuation of a public hearing for Extension No. 3 of Water District No. 1 on Tuesday, May 22, 2012 at 6:50 p.m. at the Moreau Town Hall, located at 61 Hudson Street, Town of Moreau, County of Saratoga, New York. All persons interested in this matter shall be heard at the said date and time.

This Order and Notice of Public Hearing was duly adopted by resolution of the Town Board of the Town of Moreau on May 8, 2012.

Attorney Buettner stated that this public hearing was a continuation of a public hearing that was originally held on May 8, 2012 and that had to be re-advertised to correct an inaccuracy in the first public hearing notice regarding the source of the water supply. She spoke with Tim Burley the engineer for the Town and they reviewed the map, plan and report. She noted that a letter has been received from SHPO. She also noted that since this district extension was not started by an official petition the establishment of the extension will be subject to a permissive referendum. If the Town Board chooses to establish the district extension tonight then the Town Board can close the public hearing after hearing any and all public comments and then the board can proceed with completing a long form EAF under SEQRA and declare a negative declaration under SEQRA and then resolve to establish the district extension.

Supervisor Jenkins asked if anyone present wished to be heard on this proposed Extension 3 of Water District 1.

There was no response.

Councilman Kusnierz asked how many water users will be in the district extension.

Councilwoman LeClair, Supervisor Jenkins and Attorney Buettner replied. The consensus was that there will be about 23 water users.

Jesse Fish, Water Superintendent, stated that it is important that the Town Board reach out to the property owners in the district extension area and explain to them what will happen down the road if they don't hook up to the water system now and they decide to later. It will prevent a property owner from coming to the Town Board years later and saying that they weren't given the option to hook up. This is occurring now in the current water project and there is a lot of he said, she said going on.

Attorney Buettner said she would get together with Tim Burley and draft a letter that could be given to the property owners explaining everything and the Town Board could approve of the letter first.

Councilman Kusnierz asked how other municipalities handle this. Do they do a formal outreach? Do they have a record of it that they keep in Town Hall or the Water Department. He said we have had people in other water districts come to the board and say that they were never notified.

Supervisor Jenkins said that is essentially what they are going to hear from people in Water District 5, because that line was put in by the developer. There were some people who said they asked the developer or his contractor about hooking up and were told they couldn't. Some people on the west end of the road had to pay for it themselves. It was a cost of \$1,100.00 back then and now it is \$3,100.00. They will state that they were never offered the opportunity to hook up and they expected someone to contact them. He thought what Councilman Kusnierz was saying was that we should deliver letters by hand to the property owners on Sisson Road and he said he could do that and maybe Councilwoman LeClair would help him and Councilwoman LeClair said she would. The people would at least be aware of it and know what is going on. He said amazingly enough, some of the people who live on Fortsville Road and who were opposed to the water have hooked up to the water system.

Councilman Kusnierz stated that he would like a form drafted that the property owners would sign acknowledging that they don't want to be hooked up and it should be filed in Town Hall and if they don't sign then we assume they want to hook up.

Councilwoman LeClair asked if he was talking about an opt out rather than an opt in and Councilman Kusnierz said yes.

Supervisor Jenkins and Councilman Vittengl agreed with this suggestion.

Supervisor Jenkins asked if anyone else wished to be heard.

There was no response.

Supervisor Jenkins asked for a motion and second to close the public hearing.

A motion was made by Councilwoman LeClair and seconded by Councilman Vittengl to close the public hearing on Extension 3 of Water District 1 at 6:58 p.m.
